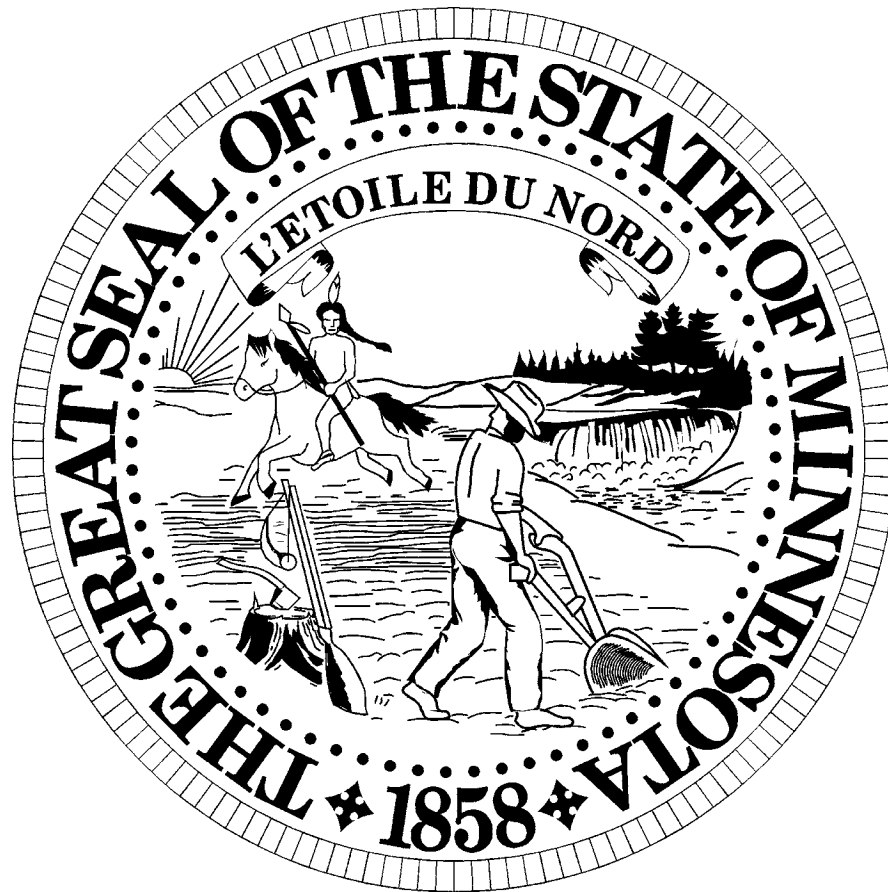

Minnesota Rules: Amendments and Additions

NOTICE: How to Follow State Agency Rulemaking in the State Register

The State Register is the official source, and only complete listing, for all state agency rulemaking in its various stages. State agencies are required to publish notice of their rulemaking action in the State Register. Published every Monday, the State Register makes it easy to follow and participate in the important rulemaking process. Approximately 80 state agencies have the authority to issue rules. Each agency is assigned specific Minnesota Rule chapter numbers. Every odd-numbered year the Minnesota Rules are published. Supplements are published to update this set of rules. Generally speaking, proposed and adopted exempt rules do not appear in this set because of their short-term nature, but are published in the State Register.

An agency must first solicit Comments on Planned Rules or Comments on Planned Rule Amendments from the public on the subject matter of a possible rulemaking proposal under active consideration within the agency (Minnesota Statutes §§ 14.101). It does this by publishing a notice in the State Register at least 60 days before publication of a notice to adopt or a notice of hearing, or within 60 days of the effective date of any new statutory grant of required rulemaking.

When rules are first drafted, state agencies publish them as Proposed Rules, along with a notice of hearing, or a notice of intent to adopt rules without a hearing in the case of noncontroversial rules. This notice asks for comment on the rules as proposed. Proposed emergency rules, and withdrawn proposed rules, are also published in the State Register. After proposed rules have gone through the comment period, and have been rewritten into their final form, they again appear in the State Register as Adopted Rules. These final adopted rules are not printed in their entirety, but only the changes made since their publication as Proposed Rules. To see the full rule, as adopted and in effect, a person simply needs two issues of the State Register, the issue the rule appeared in as proposed, and later as adopted.

The State Register features partial and cumulative listings of rules in this section on the following schedule: issues #1-26 inclusive (issue #26 cumulative for issues #1-26); issues #27-52 inclusive (issue #52, cumulative for issues #27-52 or #53 in some years). A subject matter index is updated weekly and is available upon request from the editor. Expedited Emergency Rules

Provisions exist for the Commissioners of some state agencies to adopt expedited emergency rules when conditions exist that do not allow the Commissioner to comply with the requirements for emergency rules. The Commissioner must submit the rule to the attorney general for review and must publish a notice of adoption that includes a copy of the rule and the emergency conditions. Expedited emergency rules are effective upon publication in the *State Register*, and may be effective up to seven days before publication under certain emergency conditions.

Expedited emergency rules are effective for the period stated or up to 18 months. Specific *Minnesota Statute* citations accompanying these expedited emergency rules detail the agency's rulemaking authority.

Adopted Expedited Emergency Game and Fish Rules: Taking Sharp-Tailed Grouse and Prairie Chickens

Notice is hereby given that the above entitled rules have been adopted through the process prescribed by *Minnesota Statutes*, section 84.027, subdivision 13(b). The statutory authority for the content of the rules is *Minnesota Statutes*, sections 97A.434, subdivisions 1 through 4; 97B.605 and 97B.716 subdivisions 1 through 3.

The following conditions do not allow compliance with *Minnesota Statutes*, sections 97A.0451 to 97A.0459: Sharp-tailed grouse and prairie chicken seasons are subject to adjustment on an annual basis based upon current biological and harvest data. Population and harvest data used for setting quotas and areas is gathered annually and analyzed.

6234.0300 TAKING SHARP-TAILED GROUSE.

[For text of subparts 1 and 2, see Minnesota Rules]

Subp. 2a. **Northwest Zone.** The Northwest Zone for taking sharp-tailed grouse is that portion of the state's open area lying west of the following described boundary line:

Beginning at the intersection of Voyageurs National Park and the northern boundary of the state; thence along the western boundary of the park to the public access to Lake Kabetogama at Gappa's Landing; thence along County Road 523, St. Louis County, to County State-Aid Highway (CSAH) 123, St. Louis County; thence along CSAH 123 to CSAH 122, St. Louis County; thence along CSAH 122 to United States Highway (US) 53, thence along US 53 to State Trunk Highway (STH) 73; thence along STH 73 to the intersection of STH 73 and STH 1.

Subp. 3. **Open season.** Sharp-tailed grouse may be taken by firearm or bow and arrow from the Saturday on or nearest September 16 to November 30 in the Northwest Zone.

6237.0400 TAKING PRAIRIE CHICKENS.

Subpart 1. **Open season and methods.** Prairie chickens may be taken during the ~~five-day~~ nine-day period beginning on the last Saturday nearest ~~October 20~~ in September.

Subp. 4. **Open areas.** Prairie chicken permit areas are open for the prairie chicken season as prescribed by the

commissioner. Prairie chicken licenses are valid only in the prairie chicken permit area specified on the license. The following prairie chicken permit areas, as described in part 6237.0550, are open: 803A, 804A, 805A, 806A, 807A, 808A, 809A, 810A, 811A, 812A, and 813A. A total of 125 licenses will be distributed.

6237.0550 PRAIRIE CHICKEN PERMIT AREA DESCRIPTION.

Subp. 2. [See repealer.]

Subp. 3. **Area 803A.** Prairie chicken permit area 803A consists of that portion of the state lying within the following described boundary:

Beginning at the intersection of United States Highway (U.S. US) 59 and State Trunk Highway (STH) 32; thence along U.S. 59 to U.S. 2; thence along U.S. 2 to STH 32; thence along STH 32 Pennington County State-Aid Highway (CSAH) 3; thence along US 59 to US 2; thence along US 2 to US 75; thence along US 75 to Polk CSAH 21; thence along Polk CSAH 21 to Pennington CSAH 3; thence along Pennington CSAH 3 to the point of beginning.

Subp. 12. **Area 812A.** Prairie chicken permit area 812A consists of that portion of the state lying within the following described boundary:

Beginning at the intersection of State Trunk Highway (STH) 32 and STH 113; thence along STH 113 to United States Highway (US) 59; thence along US 59 to US 10; thence along US 10 to STH 32; thence along STH 32 to the point of beginning.

Subp. 13. **Area 813A.** Prairie chicken permit area 813A consists of that portion of the state lying within the following described boundary:

Beginning at the intersection of State Trunk Highway (STH) 32 and Polk County State-Aid Highway (CSAH) 1; thence along CSAH 1 to United States Highway (US) 59; thence along US 59 to STH 113; thence along STH 113 to STH 32; thence along STH 32 to the point of beginning.

REPEALER. Minnesota Rules, part 6237.0550, subpart 2, is repealed.

EFFECTIVE PERIOD. The emergency amendments to Minnesota Rules, parts 6234.0300, 6237.0400, and 6237.0550, expire December 31, 2021. After the emergency amendments expire, the permanent rules again take effect, subject to any permanent rule amendments that have been adopted in the interim.

Notice of Public Interest Review Applications for New Hospital Beds and Opportunity for Public Comment

NOTICE IS HEREBY GIVEN that the Minnesota Department of Health (MDH) has received two concurrent filings under *Minnesota Statutes* 144.552 requesting public interest reviews. PrairieCare has filed an intent with MDH to add 30 licensed beds to the existing pediatric and adolescent specialty psychiatric hospital in Brooklyn Park. Regions Hospital has filed an intent with MDH to add 45 licensed beds at an existing level I trauma acute care hospital in Saint Paul. Five of the 40 new beds at Regions Hospital would be dedicated to inpatient mental health services.

Under Minnesota Statute, a hospital seeking to increase its number of licensed beds or an organization seeking to obtain a hospital license must submit a plan to MDH. MDH is required to review the plan and issue a finding within 150 days on whether the plan is in the public interest.
