Background:

The Minnesota Department of Health (MDH) is considering modifications to the communicable disease reporting rules through the rulemaking process. This rulemaking process will address new and emerging communicable diseases, remove unnecessary provisions, clarify reporting conditions, and address other technical changes.

MDH published the "Request for Comments" in the January 17, 2023, State Register and will be accepting comments until 4:30 p.m. on Monday, March 20, 2023.
