

# Dose-Level Eligibility Codes and Minnesota Vaccines for Children (MnVFC) and Uninsured and Underinsured Adult Vaccine (UUAV) Eligibility Status

Providers can submit Minnesota Vaccines for Children (MnVFC) and Un- and Underinsured Adult Vaccine (UUAV) program eligibility status at the vaccine dose-level to the Minnesota Immunization Information Connection (MIIC) through electronic data submissions.

## What is dose-level eligibility?

Dose-level eligibility (DLE) is a person’s program eligibility status or insurance status tracked at the vaccine dose-level.

## Reporting DLE information

All immunization providers are encouraged to submit DLE information to MIIC. Clinics enrolled in the MnVFC program that practice the replacement method of vaccine management are required to submit DLE information to MIIC for all vaccines administered to patients ages 18 years and younger. Submitting DLE to MIIC is optional for clinics that are not in the MnVFC or UUAV programs and/or that use the separate stock method of vaccine management. Providers should discuss how to submit this information to MIIC using their current system with their technical staff and/or Electronic Health Record (EHR) vendor support.

## Data quality and utilization of DLE for programmatic activities

All clinics enrolled in the UUAV program that wish to use DLE as the mechanism for reimbursement in the Bridge Access Program must not submit more than 10% of their DLE codes as blank or “unknown/not determined” (V00).

Underinsured: Has health insurance that does not cover one or more vaccines.	V05 for non-covered vaccines, V01 for covered*	Only at LPH, FQHC, RHC, IHS and tribal health clinics	No

Underinsured: Has health insurance that caps prevention services at a certain amount.	V05 for vaccine given once the amount is reached, V01 for vaccines given before the amount is reached*	Only at LPH, FQHC, RHC, IHS and tribal health clinics	No

**Patients age 19 years and older**

Patients' status	Codes to document screening	MnVFC eligible	UUAV eligible
Insured: Has insurance that covers the cost of all vaccines	V01	No	No
Uninsured OR has health insurance that does not cover one or more vaccines OR has health insurance that caps vaccine coverage at a certain amount	V23	No	Yes

**Special use codes**

Patients' status	Codes to document screening	MnVFC/UUAV eligibility
Unknown/Not determined	V00	Not applicable: Screening must occur for MnVFC/UUAV eligibility to be determined
Special vaccine projects (MDH approved)	V07	Project specific

\*Since underinsured children cannot receive MnVFC vaccine at private clinics, private clinics have the option of documenting underinsured children as V01. Underinsured children seen at LPH, FQHC, RHC, IHS and tribal health clinics should be documented as described in the above table.
